## STATUE OF LIBERTY

Seattle, Washington--The pledge goal of \$1 million toward the restoration of the Statue of Liberty has been reached by the Benevolent and Protective Order of Elks (BPOE), it was reported today in Seattle at the 121st Annual Convention of the BPOE.

Last year, the Elks received nationwide attention and praise from President Reagan when they announced their pledge of \$1 million toward the restoration of the historic New York Harbor statue. They were the first fraternal organization to commit themselves to a given amount and are the first organization to obtain their goal and submit their money. According to Vincent R. Collura, Chairman of the Elks Grand Lodge Americanism Committee, "We have not only said we were going to raise the money, we have accomplished it as well." Vince presented a check for \$1,028,000 to the Grand Lodge for Statue of Liberty restoration and said the fund is still growing. Lincoln Lodge was given a

special recognition for contributing \$5,000 to date. Vince Collura will present a certificate at a later date.—Average of approximately \$14 per member.

The Elks have been actively implementing this program for the past year and a half and had planned on reaching their goal of \$1 million by the opening of this year's convention in Seattle. "This program has done more than raise money for the Lady in the Harbor," said Collura, "it has also instilled a new sense of patriotism throughout our organization and our nation."

During the 1984-85 year, the 1.6 million member Elks organization donated more than \$28 million to various charities. Since the Elks began keeping records 105 years ago, more than \$510 million has been donated for charitable purposes. These figures do not include contributions of time, transportation, materials and expenses which last year added another \$32 million.

## Bowling league

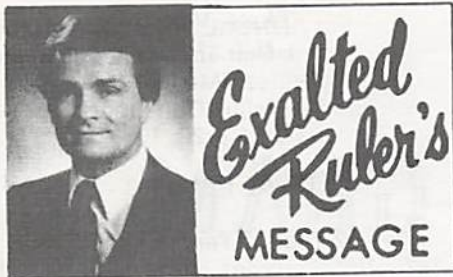
The Elks #80 Bowling League will start the 1985-86 bowling season on Tuesday evening August 27th at 9:00 P.M. at the Plaza Bowl.

## Health tip of the Month

I would like to focus in on two heat illnesses that are usually taken for granted. Despite warnings, cases of heat exhaustion and heatstroke occur each year, sometimes ending in death.

People who participate in outdoor activities, such as long distance running are particularly likely to be victims of heat problems.

Heat exhaustion is caused primarily by an excessive loss of water. Symptoms of heat exhaustion are dizziness or fainting, headache, cold and clammy skin, and profuse sweating.

This condition can usually be reversed. Have the individual lie down in a cool place and drink cool liquids. Remove excess clothing and rub the victim's body with a cold, wet towel. The victim should be instructed to stay out of the heat for the rest of the day.

Heatstroke is a less common, but more serious condition. It occurs when the body ceases to sweat, thereby eliminating the primary mechanisms of heat loss.

Indications of heatstroke are warm, dry skin, temperature of 105° or higher, disorientation and acute confusion, followed by unconsciousness.

Heatstroke is a true emergency, and chances of survival depend greatly on how rapidly treatment is received. The first priority is to reduce the victim's core temperature as quickly as possible.

Take the victim out of the sun, remove all excess clothing and apply cold, wet towels to the trunk, abdomen, and extremities. Fanning the victim to stimulate air flow is also helpful. As soon as practical the victim should be transferred to an emergency room prepared to deal with this situation.

Heat illness can be prevented by gradually acclimating the body to hot weather, providing adequate fluid replacement, and monitoring heat and humidity so exercise can be curtailed when indicated.

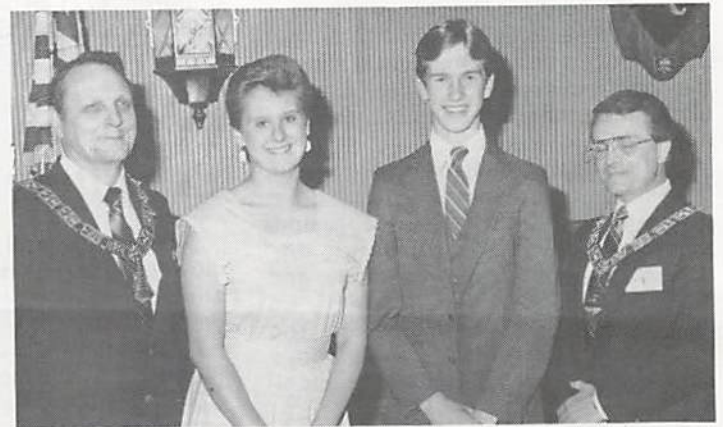
