Youth Scholarship Night at Southeast Community College

On May 3, a crowd estimated at 500 attended the Lincoln Elks Lodge #80 Youth Night held at Southeast Community College. On that night 26 seniors from area schools were honored with Scholarships, and 206 Junior Class members from area schools were presented Certificates of Excellence in 26 scholastic and extra-curricular activities.

The value of the scholarships range from \$675 to \$4,000. All of the scholarships are administered by the Lincoln Lodge #80 Charitable Fund Inc. This year 16 were given in the name of individuals and groups associated with the Lodge, and 10 were awarded by the Lodge. Past Exalted Rulers of the Lodge fund 9 scholarships in their name or in a loved one's name. For example, Wesley Durst PER and one of the founders of the Charitable Fund, provides 2 scholarships - one in his name and one for his late wife, Joanne - each worth \$4,000 over 4 years. The Paulding and Esther Smith Memorial Youth Fund provides all the money for the Lodge scholarships and in addition subsidizes the Charitable Fund Awards.

FLAG CEREMONY

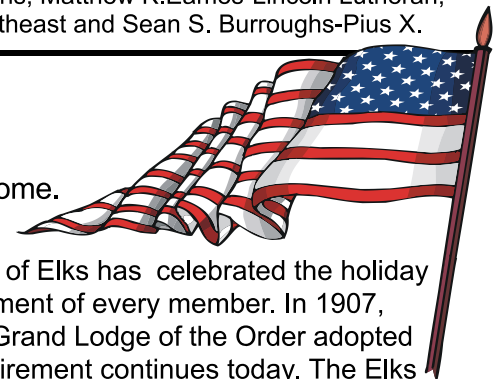

I do not claim to know all there is to know about attracting new Members and holding on to them. However, I offer some thoughts on the subject.

In my book, membership boils down to what we do, how well we do it, and how what we do is perceived in the community. An active Lodge, working relevant projects, will draw interest. We then need to be geared to ask, "Are you an Elk? Would you like to be one?"

We are all busy people. We spend much time working and child-rearing. We seem to have little time to do volunteer service activities. Yet, with all of that, there are some folks who would want to participate in a family-oriented Elks Lodge that has a Hoop Shoot Free Throw Contest, a Drug Awareness Pool Party, a Veterans' Picnic, the Antlers, and so on. An Elk We Should Never Forget

Jim Rakers, PER April 17, 1934 - April 30, 2010

He was born in New York and always retained his "accent," though he lived in Nebraska for 40 years. I recall that his first job was that of a door-to-door salesman, his product, Kirby vacuum cleaners. He left this occupation and with his wife, Dianne, entered the US Air Force. His last assignment was at the Lincoln Air Force Base, Lincoln, Nebraska. While here he attended the University of Nebraska and received his BS in Science Education. While in university he was active in the men's honorary education groups. He continued his military service in the Nebraska National Guard as a helicopter pilot. He then began his teaching career at Irving Junior High and this is where I first met Jim. He was a science teacher and then later became a school counselor. He was a remarkable blend of intelligence, creativity, warmth, and daring.

When Jim was working on his masters degree, he was doing some intelligence testing on young children and he asked if he could test my daughter, Kathy. I listened carefully and everything went well until Jim pronounced the word "roar" and Kathy answered "what a lion does." Jim then said "no I mean roar" and Kathy gave him the same answer. I then looked over Jim's shoulder and said "Jim, the word as we pronounce it is "raw." You can appreciate the humor of this if you ever heard his very prevalent New York accent.

While very involved with his career, Jim joined the Elks Lodge and within a few months he was the lodge Americanism Chairman and the Youth Activity Chairman. He served in this role for 22 years until he became Exalted Ruler. One evening after Jim became an officer he was asked to give the 11 O'Clock toast, something that was done every night at that time. Jim had his notes and was all ready to go when Ron Colin turned out all the lights and Jim had no script to follow. This was absolutely the last time Jim was unprepared for anything. Jim was involved in every aspect of the lodge and his wife Dianne was extremely active in the Does Drove # 4.

Lincoln Elks Lodge #80 is most indebted to Jim for something he did during his term as Exalted Ruler. Yes, he was All State as Exalted Ruler and he led the team to the Nationals in Texas where we placed third, but something else was even more significant. The lodge on South 70th was leased from member Joe Hampton. Jim formed a committee to consider

purchasing the building on contract from Joe Hampton. The lodge agreed to buy the building and the payment was the same as we had been paying for rent. At the end of four years it was apparent that the pool needed to be replaced, the building needed \$400,000 in repairs, and we could not afford the building. The good news of this entire process was that the value of property increased tremendously during the 4 year period. With the help of PER Ron Colin and member Harry Hoffman were able to sell the old lodge to The Sutton and Linder group which is now the site of Eye Surgical Associates. Because we owned the building and the land, we had an asset to sell. The sale created the major portion of the funds to build our present lodge. We owe Jim a debt of gratitude.

As a PER, Jim continued to work for the Elks as chairman of the scholarship committee and also of the State Scholarship Committee. Jim was solely responsible for the establishment of the Elks Scholarship Fund. Others helped but it was Jim's thinking and effort which brought this fund to fruition. Even after he moved to Arizona, Jim Rakers remained aware of the lodge activities and always had his heart in Lincoln Elks Lodge Number 80 and all the children which this lodge has assisted. Jim was a true Elk and one we should always remember for who he was and what he accomplished for Number 80.
