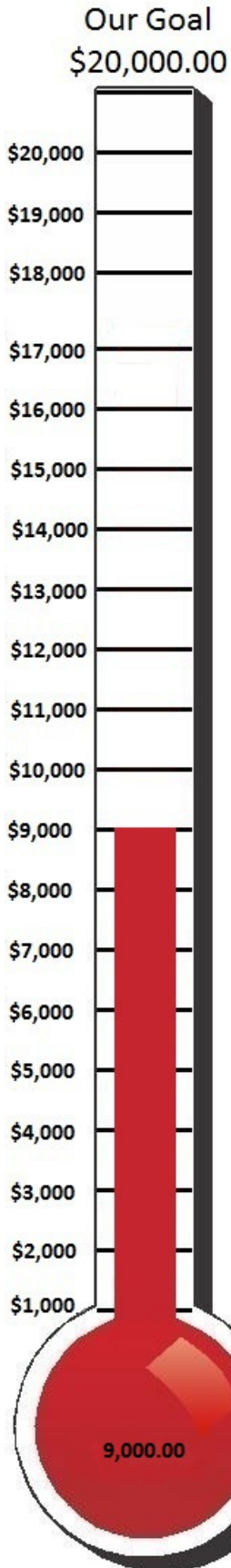

... Our condolences to Rose Dow in the loss of her husband and our long time member, Bernie Dow. Bernie was one of the nicest guys you'll ever meet, always thinking of and doing things for others. He had even chipped in on our HVAC fund, bless his heart. He will be sorely missed, not only at the Lodge, but in all the many other areas of life he touched. Church, Shriners, Elks, Family, etc. He was a stellar example of an Elk ... Larry Bratt is rallying everyone to raise a little extra money for ENF, we'd like to get over \$10 per person for our Lodge. Our goal is only \$4.60 per person from Grand Lodge, and we have already doubled that and then some. So why the push to go to \$10? We get so much more back from ENF than what we put in. Our membership is right around 265 people, and at \$10 a head, that is only \$2650.00. We have already received \$4000 in grants from our participation in ENF. I am so pleased we have younger members like Todd, who understand the importance of benevolence, and who understand modern technology and are willing to help those of us a little "electronically challenged", to get with the program. 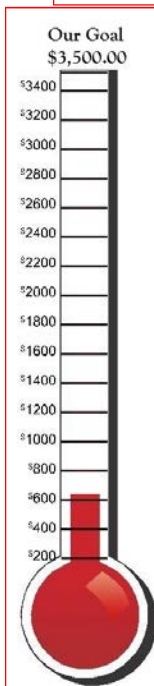

Remembering Andy Harvey

April 25, 1983 – September 26, 2013

I would like to take this time to remember Andrew (Andy) Harvey, Andy was a young man who passed away at an early age of 30. Not a lot of the members here at Lodge # 80 probably knew Andy unless you were involved with the Elks Midget Football Program.

Andy was a cornerstone of this program and his leadership over the past 20 years has made this program the success that it is. Andy left a solid foundation on which to build. How many individuals could ever lay claim to the fact that they had volunteered for 2/3 of their life to a cause. Not many, Andy was one of a kind, in 30 short years he had already amassed 20 years in the Elks Program.

Andy played for the Elks for 4 years and then went on to play for Lincoln Northeast High School. Even after his own practice sessions would end, Andy would come back down to the fields and help Coach the Elks players for the remainder of the evening. After graduating from High School Andy became a Coach. He had held every position known to our program, Asst. Coach and Head Coach at all levels and Athletic Director. If it needed done, Andy would see to it that it got done.

Andy had a strong dedication to the youth of this community. He would take the time to know each and every player and their families, when he saw one struggling to fit in, he found a way to get the others around him or her to support that individual.

Andy was never officially an Elk but as a "Mentor" and a "Role model", he set the bar pretty high for all to follow. As fellow Elks we should be Proud of what Andy has done for this program.

Almost all members have a child, grandchild, step-child or step-grandchild eligible for our Legacy scholarships which are for Elks members families.

Here are three reasons why: 1) The students place of residence is immaterial. They do not have to live within our Lodge jurisdiction – just be related to a member as stated above.

2) If the member sponsoring is currently active and has been for 5 years or if a deceased members name is used, and that member was a paid up member for 10 years prior to his/her death, that child, grandchild or step-child, step-grandchild is eligible to apply.

3) Any senior in High School or any student in school, up to the age of 25, can apply. Most scholarships apply to High School Seniors only, but ours let older students, who still can use a little financial help, get a piece of the pie.

Marty Mienzer, State Ritual Chairman and his wife Dawn from York hosted the event. National Ritual Chairman from Area 6, Allen Lenort, put on a very informative clinic. There were 15 Nebraska Elks in attendance of which 10 were from Lincoln Lodge #80. Your officers performed the stop and go during the morning session as well as the judges certification and re-certification floor performance in the afternoon. The 8 judges provided valuable critiques for each of Lincoln's officers except for Candidate Wirth who was spot on.
