Knight's Tales






...and now for the Quickies...

This Could Happen to Us!!

Our Lodge recently received a letter from the National BPOE in regards to a situation that occurred with the Pittsburgh Elks Lodge #11. A jury awarded the victims of a car crash more than \$28 million in damages. This stemmed from a fatal car accident in which the driver of one of the vehicles had attended a function at the Elks Lodge where he was drinking alcohol. After leaving he was involved in an accident that killed a 24 year old driver of another vehicle upon impact and lead to the death of a passenger in the other vehicle seven months later. This accident also injured two other people. The man that had been drinking at the lodge tested almost three times the legal limit for blood alcohol and because he had been drinking at the Elks Lodge and served alcohol way past legal intoxication, the Elks Lodge was found to be 40 percent liable and therefore had to pay 40 percent of the amount awarded to the victims and their families.

Locally, in Omaha, a waitress was also convicted of over serving a person who then later was killed in a one vehicle accident in which the deceased was driving. Prosecutors said that someone should be held accountable and the jury agreed.

These are situations that could happen here very easily and we are most likely lucky that it hasn't yet. All of us at some time have probably drank to the point of being over the legal limit (which is 0.08) in Nebraska. It is our responsibility to not let these two incidents be repeated in our lodge. We all need to be responsible in both drinking and serving and realize that if we are told that we cannot be served any more alcohol at some time, that we need to respect that and understand that this is not being done for any reason other than your safety and the safety of others and our Lodge.

In this day and age lawsuits can be brought against not only the driver or person responsible for an injury, but also against the person serving them *and* the establishment they were drinking at. I know that none of us want to lose our Lodge due to any incidents like these. We also do not have the funds to be able to survive this type of judgment, not to mention the damage to our Order's reputation in the community. Please help us to avoid having to deal with any situations like these and always be responsible drinkers and Lodge members.
