

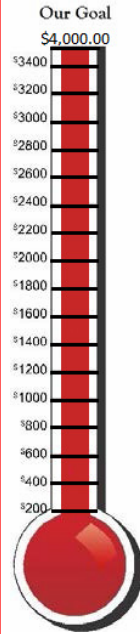

**Volunteers, ENF Grants
Help 'Elevate America'**

Now is the time to finalize your plans for obtaining Elks National Foundation grants for your Lodge. Most Lodges have now achieved my \$4.60 per-capita goal for giving to ENF and have thus qualified for a Gratitude Grant. If your Lodge has not yet achieved the goal for the 2014-2015 Lodge year there is still time to make it so get busy. March 31 is the cut-off date to donate to the ENF. The Gratitude Grant of up to \$2,000 can be used for a variety of charitable community needs. Gratitude Grant applications are due no later than May 31, 2015.

Next consider and plan for a \$2,000 Promise Grant. A Promise Grant project must serve youth in need and events are required to be alcohol- and drug-free. This year's projects must be completed by July 31, 2015. Promise Grants are limited to the first 500 qualifying applications and new applications will be available July 1 for next year.

Beacon Grants are designed for ongoing, Elks-led, charitable community activities and the grants are available for up to \$2,000. These grants require bona fide "Elk involvement". Simply handing a check to a charity does not achieve our goal of elevating the status of the Lodge in the community through active Elk participation of worthy community projects. Any Lodge may apply and projects must be completed by July 31.

Freedom Grants, managed by the Veterans Service Commission, are oriented to projects that serve veterans or active duty military personnel and/or their families. They are competitive, limited in number, and the application period is August 1 through August 31. Active Elk involvement is also required.

If you have a major community project in mind, an Impact Grant from ENF may be just the ticket. These grants are available for large scale, Elk-run service projects of up to \$10,000. The grants are competitive and require significant Elk involvement and community presence.

This summary will serve as your reminder of the various grants funded by Elks National Foundation – "The Great Heart of Elk-dom". Do not miss the opportunity to Elevate America and your community by taking advantage of the ENF grant program. Your community and your Lodge will be the beneficiaries!

107th Children's Christmas

The 107th Children's Christmas party is now in the record books. This was the first year that the party was held at Pinnacle Bank Arena. What an exciting new venue! Tom Lorenz and his staff bent over backwards to help us. Every time we needed something, or had a question, they were there to assist us. A huge "Thank You" goes out to Tom and his staff.

The festivities officially started on Friday, December 19th at the sacking party. In past years, we had enough volunteers to efficiently run two production lines to make the goody bags. This year we had a huge turnout (55 people), and could have set up another full production line. Due to the anticipation of higher attendance for this year's party, we made 1800 bags of goodies, instead of the normal 1500 bags. When PER Jeff Sneller went to pick up the apples and oranges for the goody bags, he discovered that there had been a miscommunication, and there wasn't an order waiting for him to load. Jeff was able sweet talk the supplier into getting the order together on short notice, and delivered the fruit to the arena in time to get the assembly line started on time. The assembly line then started and ran smoothly. The 1800 bags were sent down the assembly line and then packed into the carts at the end of the line.

On Sunday morning, December 21, several people arrived at the arena a little before 10:00 and began unloading the toys from the trucks. The toys were then taken into the ticket office and arranged by age group. Heather Pedersen and some of her music students arrived and set the tone for the event by entertaining everyone with Christmas music as they entered.

Attendance for the last couple of years has been in the 1300 to 1350 range. This year we had more than 2100 people in attendance. The arena staff had to enlarge the seating area in order to accommodate the overflow crowd. We were hoping to increase attendance this year, but were amazed at how many people came to this great event. I was out front by the doors most of the time, and people just kept coming and coming! As the kids entered the arena they were each given a candy bar. Kids that received a candy bar with winner sticker on it were escorted into the ticket office where they selected a toy of their choice. Needless to say, we had hundreds of happy kids. If the kids didn't receive a candy bar with a winner sticker they were directed to either of two tables that had coloring books. The coloring books were provided by Dave Ulferts. Dave is a member of the Lincoln Lodge who lives in Omaha. Dave worked with Omaha North High School in obtaining 25 free cases of coloring books. Thanks go out to Dave for getting the coloring books, which meant that every child was a winner.

Laurie Montag was our Master of Ceremonies this year and did an excellent job. She really got the crowd going when the entertainment was over, and she kept asking the crowd if there was anything that we needed to do. Of course the kids all hollered something about Santa.

This event couldn't have taken place without all of the members and their families who came out to volunteer at both the sacking party and the Christmas party, and also those who donated to this wonderful event. It makes me proud to be an Elk!

We had 55 people who drove a total of 888 miles and put in 160 hours to help with the sacking party.

We had 43 people who drove a total of 580 miles and put in 210 hours to help with the Christmas party.

We had 4 people who drove a total of 403 miles and put in 100 hours to shop for the candy and toys, pick up the coloring books from Omaha, and do several other tasks.

The grand total was 102 people, 1871 miles traveled and 470 volunteer hours. This party makes a large impact on our community, and takes a huge commitment from our members to make this such a wonderful event for all of the families that attend.
